

# BEHAVIORAL INTERVENTION TEAM POLICY

Division: Student Affairs

# **Policy Statement**

The Terra State Community College (TSCC) Behavioral Intervention Team (BIT) is comprised of specific faculty, staff, and administrative members and has been developed to promote a safe environment for the campus community that is focused on enhancing student learning and student development.

## **Policy Details**

The Behavioral Intervention Team seeks to increase communication, collaboration, and coordination regarding behavior that raises concerns or disrupts the College learning environment. The BIT enhances campus safety and promotes success by providing a centralized listening and response function regarding concerning behavior. This includes providing resources and support to those dealing with the situations as they emerge, tracking and assessing incidents and patterns of incidents, responding to the individuals involved along BIT guidelines, and documenting.

All College employees (with limited exceptions), including faculty, administrators, staff, and residence advisors, are identified as mandated reporters and must report any incidents of possible sexual harassment, sex discrimination, or sexual violence in which they are aware. (Please see "Procedures" for reporting details)

Individuals are allowed to make anonymous reports; however, if a name is not provided, it may hamper the team's ability to seek follow up information that may be critical in determining an appropriate course of action. If a name is provided the team may provide feedback regarding actions taken.

The Behavioral Intervention Team is a multidisciplinary team that meets regularly to serve five major functions for the College:

- 1. Provide consultation and support to members of the College community in assisting individuals who display concerning or disruptive behaviors.
- 2. Respond to reports, gather information to assess situations involving individuals who display concerning or disruptive behaviors; engage reported individuals in a process aimed at correcting the disturbing behavior.
- 3. Recommend appropriate intervention strategies or disciplinary sanctions.
- 4. Connect individuals with needed campus and community resources.
- 5. Monitor ongoing behavior of individuals who have displayed disruptive or concerning behavior.

In any situation involving reporting, privacy concerns emerge. Privacy is a high priority of the BIT. Records and proceedings of the BIT are kept confidential and shared only on a "need to know" basis in a manner that is consistent with Family Educational Rights and Privacy Act (FERPA) and College policy and procedures. While every effort will be made to protect privacy of both the reporting individual and person of concern, situations that potentially involve danger or harm require that action be taken to protect those at risk.

#### **Procedures**

Examples of what to report (but are not limited to):

Rudeness or insubordination

#### Behavioral Intervention Team Policy

- Classroom disruption
- Drunkenness or under the influence of drugs
- Threating words of actions
- Communications that convey clear intentions to harm self or others
- Hazing
- Flat affect (emotionless)
- Overdose
- Illegal activity
- Self-injurious behavior
- Social media postings that are direct and explicit
- Suicidal threats, gestures, ideation, or attempts
- Paranoia or delusional behavior
- Acts motivated by hatred or discrimination

#### **Title IX Disclaimer**

The following sexual misconduct incidents may also be reported to the Title IX Office at Report a concern: Examples of sexual acts motivated by hatred or discrimination include but are not limited to:

- Concerns are reviewed during normal business hours, unless deemed an emergency and/or high risk.
  If your concern involves an immediate safety risk to self or others, call 911 immediately and then

BIT	Behavioral Intervention Team	
NABITA	National Association for Behavioral Intervention and Threat Assessment	
Mandated Reporter	An employee of the College who is obligated by this procedure to immediately share knowledge, notice, and/or reports of sexual misconduct and/or retaliation with the Title IX Coordinator. This includes the President, Vice Presidents, officers within the Department of Campus Safety, all Deans, Chairs, Directors, Department Heads, Student Organization Advisors, Academic Advisors, Career and Transfer Advisors, Advocates, admissions staff, human resources staff, and Athletic Coaches. All mandated reporters must promptly share all details under these procedures with which they observe or have knowledge.	
Flat Affect	Flat affect is a condition that causes people to not express emotions in the same way other people might. For example, when a person without flat affect is happy, they may smile brightly or in some other way show that they're pleased. A person with flat affect shows no facial expressions	
FERPA	Family Educational Rights and Privacy Act of 1974. Federal law governing access to records maintained by educational institutions and the release of information from those records. FERPA requires the institution to send a notice to enrolled students annually.
